CONSULTATION INFO IN-PRACTICE or TELE/VIRTUAL

This may seem like a lot of information to read through, but I need you to be well informed as to the process of consulting with a Clinical Naturopath who works wholistically using a comprehensive Integrative & Functional Medicine approach.

YOUR FIRST 10 MINUTE INTRODUCTORY TELE-CHAT IS FREE

Deciding to commit to a new doctor can be a difficult decision! You need to be able to feel comfortable and to "connect" with your new practitioner. This 10min chat (online video) gives us an opportunity to decide if we are "compatible" and if we can work together - with no strings attached and no financial commitment from you.

If you decide to work with me – then please read on....

BOOK YOUR INITIAL CONSULTATION

This takes about **3hrs** of your time (occasional longer in complex cases)

The reason it takes so long is because we are going to be covering the following:

- Your MEDICAL & HEALTH HISTORY & TIMELINE(a little bit of your life-story)
- MEDICAL SIGNS & SYMPTOMS (MSQ)
- Review of your PAST TESTS / REPORTS and/or REFERRAL info
- INITIAL PHYSICAL EXAMINATION some basics if/as needed
- Brief initial assessment of your NUTRITION/ LIFESTYLE, BOWEL MOVEMENTS

& STRESS - we will do lots more work on these as we go along

- We will then formulate an INITIAL PLAN of action:
 - EG: clinical tests to do / treatments / intro nutritional & lifestyle changes / supplements / referrals etc.

STEPS IN THE PROCESS:

- 1. COMPREHENSIVE PERSONAL INFORMATION GATHERING
- 2. EDUCATING & COMMUNICATION (practitioner and patient)
- 3. EXAMINATIONS & TESTING
- 4. NUTRITION & LIFESTYLE foundation
- 5. SUPPLEMENTS/NUTRACEUTICALS (selection, dosages, changes over time)
- 6. TREATMENTS, OTHER THERAPIES & REFERRALS
- 7. Continued COMMUNICATION & EDUC
- 8. FOLLOW-UPS & RETESTING

PLEASE REMEMBER TO COMPLETE SEND TO ME BEFORE YOUR CONSULTATION:

If you know how, you can create an online / cloud-folder and send me the link instead of emailing everything.

- CONSENT FORM (100% online) Complete at least 2 full working days BEFORE your consultation.
- PDF Questionnaires
 (" Confirm with Dr Adele which ones you need to complete.
 Complete using a PDF editor and send to me at least 2 full working days BEFORE your consultation -OR- PRINT & complete by hand then photograph/scan and send to me. GOOD LIGHTING and CLEAR as possible please!
- 3. Any previous test results or reports get copies from your doctors / hospitals you have been to over the years (as far back as possible) and send to me at least 2 full working days BEFORE your consultation.
 - *NOTE* These are YOUR results, so you are entitled to copies for your own records, or to send to other practitioners.
- ALL medication & supplementation that you are taking at present or have in your cupboard.
 - Type out the full name, manufacturer, amounts, when you take them etc. (use this **TEMPLATE**).
 - a. You can type this LIST either on your <u>HISTORY</u> -OR- the <u>INFORMED CONSENT FORM</u> -OR- the <u>TEMPLATE</u>

« Please complete ALL forms and questionnaire, accurately and honestly!

SUPPLEMENTS, NUTRACEUTICALS, MEDICAL FOODS, NATUROPATHIC REMEDIES:

Based on your health issues, concerns, symptoms and clinical results - I may prescribe herbals/botanicals, vitamins & minerals and/or nutraceuticals, medical foods, tissue salts, Bach flower remedies etc. that you will need to take for a specific period of time (i.e. as a treatment THERAPY). It is therefore imperative that you check-in via Whatsapp regularly and/or short follow-up consultations (online is an option), so that we can adjust your program (nutrition, remedies, supplements, therapies, lifestyle etc.) - as your health, test results and symptoms change.

The LNNM Centre does stock several products that can be purchased (for your convenience you can get directly after your consult, collect from us -OR- we can courier to you). Please note that you are under no obligation to purchase any products from the LNNMC - but please be aware that all of the products have been used or vetted by Dr Adele, and prices are very competitive vs some health shops. FEES: IN-PRACTICE & ONLINE/VIRTUAL CONSULTATIONS (ZARS/SA Rands): (ANNUAL CHANGES)

- Your first 10 minute INTRODUCTORY TELEPHONIC / WHATSAPP/ ZOOM chat is FREE. Thereafter...
- INITIAL CONSULTATION SET RATE (~3hrs): In-person = R4500; Online/Virtual = R5000
- Follow-up IN-practice consultation/treatment rate: R1,500/1hr (or part thereof)
- Follow-up Online/Tele/Virtual consultation rate: R1,800/1hr (or part thereof)
 - O Note: Virtual / tele-consultations cost more vs in-practice, as there is much more preparation, planning and post-admin required.
- General Communications Telephonic, Whatsapp or Email discussions re. results, questions, queries & "mini" online consultations: < 10min = FREE, > 10min = R400 and every 15min thereafter.

NO SHOW / MISSED APPOINTMENT / LATE CANCELLATION FEE (ie: less than 24hrs before appointment) = 50% of consult/treatment time (this will be invoiced to you electronically)

PAYMENTS:

International payments – direct exchange rate equivalent to ZAR / Rand rate above (at time of consultation).
